Accomplishments

Partnerships, Collaboration, and Prevention

Participated in a series of stories aired by WJAR-TV's **Studio 10** about mental health issues and solutions to help end the stigma on mental health.

Expanded our partnership with **Bikers Against Child Abuse** to serve more young victims of human trafficking.

Chaired the **RI Continuity of Care Group** of 8-to-10 agencies, which coordinates care, shares resources, and advocates for youth and families impacted by sexual abuse.

Served as a member of the **RI Human Trafficking Task Force,** a collaboration of federal, state, and local law enforcement agencies, which prosecutes offenders. St. Mary's provided expert training to professionals about Commercial Sexual Exploitation of Children.

Contributed to the **Building Bridges Initiative's** recent book: *Transforming Residential Interventions: Practical Strategies and Future Directions*, and conducted webinars for BBI with stakeholders in multiple states on family engagement and residential transformation.

Continued to be an active member of the Rhode Island Coalition for Children and Families.

Staffing and Performance

On-boarded new positions: Chief Operating Officer; Information Technology Director; Communications and Media Specialist; Performance and Quality Improvement Specialist. Also installed a new Campus School Administrator.

Increased performance and quality initiatives, ensuring that departments and programs are working towards improved quality and reporting data for future improvements.

Offered **clinical internship placements** for local college social work students.

Developed highly collaborative and clinically effective interdisciplinary teams to work on the front lines through the pandemic.

Restructured recruitment, hiring, onboarding, and orientation processes resulting in an increase in applications from highly-qualified individuals.

Awarded the **2020 "Exemplary" Worksite Health Award** from Blue Cross Blue Shield of Rhode Island for our workplace wellness programs.

Operations, IT, and infrastructure

In response to COVID-19 restrictions, successfully transitioned the **Outpatient Department** staff to working remotely and pivoted our **George N. Hunt Campus School** to distance learning including rolling out Chromebooks for every student.

Started the **Outcomes Project** which interviews caregivers of former residential clients at 6, 9, and 12 months post discharge to determine their current level of functioning. The surveys are analyzed to increase our program effectiveness.

Upgraded our physical plant through **capital improvement projects** with a focus on energy efficiency.

Raised funds for a **Master Plan** to be completed in FY 2021 to determine the future of our physical campus and infrastructure.

Migrated the agency to **GSuite by Google**, adding collaborative features such as a help desk and asset management which increased productivity, ensured risk mitigation, and offered savings on IT infrastructure — at no cost.

Upgraded our **Library** to include an interactive touchscreen and modern work area for virtual meetings and classes. Also secured grant funding to purchase books and materials for a **multi-cultural library** at our Campus School.

Crafted a **new resource handbook** for clients containing information on St. Mary's services and programs as well as community resources.

Developed and launched a **new website** and **newsletters** to enhance the agency's donor relations, marketing and communications reach.

Residential Services

Our residential services provide treatment for youth ages 6-18 including a full range of individual, group, and family clinical services. Five houses (see right) on our campus provide living space for up to 37 youth at a time. We served 130 youth in residential.

Services offered include psychiatric evaluation, medication management, assessment, treatment planning, campus school, family search, discharge planning and aftercare services. Here is a summary of our residential services:

- Psychiatric Residential Treatment Facilities (PRTF): Three of our houses – Hope, Horton and Mauran – are classified PRTF. They are non-hospital facilities offering intensive inpatient services to youth with various mental health issues who are under age 21. The goal is to stabilize or improve a child's condition until therapeutic services are no longer needed. Youth will then step down to another group setting, foster home, or return to their family. These houses serve male, female, nonbianry, agender and transgender youth ages 6-18.
- Acute Residential Services (ARTS): Harding, the ARTS house, is a hospital step-down or diversion program which serves boys ages 6-13 and girls 6-18. ARTS includes intensive short-term stabilization and treatment (averaging 51 days per youth) after which youth will go home or into another residential setting.
- Assessment and Stabilization Services: Hills house serves teen girls and transgender youth ages 12-17. Services include clinical assessment, treatment planning, psychiatric services as needed, and individual, group and family therapy.

Our residential services are based on the principles of the national **Building Bridges Initiative (BBI)** which ensures that services and supports are family-driven, youth-guided, strength-based, culturally and linguistically competent, evidence and practice-informed and consistent with the research of sustained positive outcomes. These outcomes include: decreased readmission to congregate care, improved family relationships, home stability, and successfully living in the community. We provided aftercare services to 47 youth and their families.

DJ's story

DJ was a boy searching for a family and a home he could call his own. He could no longer live with his biological family and at age 11, came to live at St. Mary's Home for Children where he received a variety of services.

But DJ wanted so much more. At an Adoption RI picnic, he introduced himself to a prospective parent by saying, "Hello, my name is DJ. I'm half Irish and half Italian. I'm waiting to be adopted. Are you looking to adopt?"

He immediately caught the eye of Christine Hunt, a woman searching for purpose after being widowed at a young age.

The children served by St. Mary's often experience abuse and trauma, which affects them behaviorally and psychologically. For DJ, his anger was deep and damaging. At first Christine worried that she didn't have the background or knowledge to help him.

That is until she received a letter from Patty Olney-Murphy, our Director of Clinical Services, and DJ's therapist. The letter detailed all of the good in DJ and all that he was capable of achieving. The letter helped turn Christine's view around and she knew that DJ was destined to be her son.

Life after adoption has been wonderful for this family, who travels and celebrates with cookouts whenever they can.

Outpatient Services

Outpatient Services, known as The Shepherd Program, provides a variety of programs to support children, adults, and families impacted by sexual abuse, sexual exploitation, and other trauma, such as family violence and physical abuse. Here is a summary of Shepherd Program offerings:

- Office Based Counseling: Clinicians provide trauma-informed care and specialize in sexual abuse specific treatment. Served 204 clients.
- Enhanced Outpatient Services: An intensive team approach focusing on safety, stability, and achieving well-being. Served 86 clients.
- Equine-Assisted Therapy: An experiential technique where participants learn about themselves and others by participating in activities with horses, discussing feelings, behaviors, and patterns. Served 73 clients.
- **Supporting Teens and Adults At Risk:** Serves males, females, and transgendered youth vulnerable to sexual exploitation and trafficking, up to age 25. Served 73 clients.
- **Supporting Adoptive and Foster Families Everywhere:** A communitybased, team-based service focusing on preserving families formed through adoption and foster care. Served 40 clients.
- Child and Family Trauma Treatment: A community-based, teambased service focusing on supporting families with children who have experienced sexual abuse. Served 22 clients.
- Hope for Healing Groups: A series of ongoing weekly clinical support groups that focus on various areas including children/teens/adults who have experienced sexual abuse, and youth empowerment/avoiding exploitation. Served 112 clients.
- Families Impacted by Sexual Abuse Curriculum: A 12-14 week curriculum designed to provide support and education to caregivers of children affected by sexual abuse. Number served is included under Office Based Counseling.
- Trauma-informed training and consultation: Offer the Shepherd Training Series that includes CEUs as well as individual consultation and professional trainings regarding sexual abuse, sexual exploitation, or other trauma.

Nikki's Story

The day Nikki walked into St. Mary's she felt she was a shell of a human being. After suffering a lifetime of sexual and physical abuse, her sense of who she was, and what she had to offer, felt broken.

She was convinced that if she shared her experiences, she would be disliked, thought to be disgusting, and found guilty of causing the situations in which she suffered. During her first therapy session, Nikki couldn't even speak, she was so afraid that her "secrets" would get away from her and be used against her.

But Nikki's experience with the staff at St. Mary's has given her the strength to grow, to explore her worth, to learn self-care, and stop blaming herself for the crimes committed against her. Telling her story has shown Nikki that she is strong and resilient, and she doesn't need to be alone to deal with her feelings.

Being believed and having her emotions validated has empowered her to live a safer, more fulfilling life. She has learned to set boundaries that protect her and advocates for herself when necessary. Today, Nikki has been encouraged to speak her truth and stand up for herself. The staff at St. Mary's continue to work with Nikki during her healing process.

George N. Hunt Campus School

The George N. Hunt Campus School (GNHCS) provides highly structured, individualized instruction, and therapeutic services to students with learning, social, emotional and behavioral challenges. We are licensed by the Rhode Island Department of Education as a year-round, out-of-district special education school for grades K-12. The School follows RI's Common Core Standards.

Students can be referred to the campus school by Local Education Agencies to attend as a day student. The school also serves St. Mary's residential youth. All students must meet special education requirements to attend. Small class size and supportive staff ensure that individual needs are met. Our goal for all students is to prepare them to return to their public school or a less restrictive school, or to graduate ready to continue being successful learners. Here is a summary of services offered:

- Supportive learning programs are available throughout the year.
- Clinical and therapeutic support is provided to all students.
- Related services such as Occupational Therapy and Speech/ Language services are available per the student's Individualized Education Plan (IEP).
- A reading specialist is available for education evaluations and support to improve reading skills per the student's IEP.
- Support is provided for credit recovery.
- An Extended School Year program component helps students to maintain social, emotional, and academic gains, credit recovery, and includes actively engaging them in a program that emphasizes the outdoors, nature, and the community.
- A 45-day assessment program, requested by a school district, is available to determine if a student qualifies for special education services and what services should include.
- Evaluations, requested by the IEP team, to meet three-year special education eligibility requirements or to identify specific areas of need.

Aleecia's story


Aleecia came to live at St. Mary's after experiencing childhood trauma. At first the teenager hid in her room, petrified, and feeling like no one was there for her, no one cared for her or trusted her. She had become a tough kid due to life circumstances and acted out in the early days of her time at St. Mary's.

But slowly, with the help of her Residential Counselor Keyara, Aleecia came out of her shell. She realized the importance of education and worked hard to finish her high school degree. She began to understand that her future was in her hands and dug deep into her own emotions and treatment. She soon developed the goal of moving from St. Mary's to live on her own, attend college, and work.

Key to her success was the close contact of Keyara who Aleecia calls a "mother figure who she never got to have before." Aleecia, now 18, is very near her goals – she is enrolled in the Community College of Rhode Island with a nursing major. And today, she knows that St. Mary's has her back and will be her stepping stone to a great adult life.




Financials at a Glance
